ACCESS TO HEALTH

1. Any migrant in Portugal has the right to health care and a duty to protect it.
2. Any sick migrant has the right to be seen at a Portuguese Health Centre or Hospital, in case of Emergency. (Order No. 25.360.2001 of 12 November).
3. Assistance cannot be refused on the grounds of nationality-related reasons, lack of economic means, irregular situation or other circumstances.
4. If you are refused medical assistance, immediately go to the Gabinete do Utente (Patient Office) of the Health Centre of Hospital where you are and contact the Centro Local de Apoio à Integração de Migrantes, CLAIM (Portuguese Local Support Centres for the Integration of Migrants).

SNS FORM

You can get the SNS form (with a Portuguese health service number) at the Health Centre or at Loja do Cidadão, if you have a valid residence permit.

MIGRANTS | IRREGULAR SITUATION

- **Migrants who need access to the Portuguese Health Service must show their Passport and Taxpayer Number;**
- **Request from the Parish Council a Certificate of Residence, stating you are living in Portugal for more than 90 days. Two witnesses must be procured in order for this document to be issued.**

Irregular migrants do not have the right to a SNS user number (registration is sporadic) and must pay for the health care services provided to them in full except for 'public health' situations - in these cases, they are exempt from paying the moderating fees. These situations listed in item 7 of Circular No. 12, of 7 May, 2009, are:

1. Urgent and vital health care;
2. Communicable diseases who represent a danger or threat to public health (tuberculosis, AIDS and other);
3. Vaccination (Portuguese Vaccination Plan);
4. Children under 18 years of age;
5. Maternal and Child health care, reproductive health care, family planning, abortion, pregnancy, childbirth and post-partum (60 days after childbirth) and new-born health care;
6. «Foreign citizen under family reunification, whenever someone in the household makes social security discounts»;
7. Migrant under social exclusion/proven deficiency by Social Security.

PAYMENTS

All regular migrants (holders of a valid residence permit) are subject to the same principles and standards applied to the general population regarding payment and exemption of moderating fees in accordance with the Law (Ordinance No. 20/2014, of 29 January), including citizens under an agreement between Portugal and their country of origin.

Exception: Cooperation Agreements and International Conventions. Migrants holders of an agreement form must also pay the moderating fees like any Portuguese citizen.
